

End User License Agreement for QSR Software

IMPORTANT - READ CAREFULLY

This End-User License Agreement (“**EULA**”) is a legal agreement between you, the customer, and QSR International Pty Ltd ABN 47 006 357 213, of Second Floor, 651 Doncaster Road, Doncaster, Victoria, 3108, Australia (“**QSR**”) for use of the Software that accompanies this EULA as described in clause 1 below. An amendment or addendum to this EULA may accompany the Software.

YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA BY INSTALLING, COPYING, OR USING THE SOFTWARE. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS, DO NOT INSTALL, COPY, OR USE THE SOFTWARE. IN RELATION TO NCAPTURE SOFTWARE AND NVIVO SERVER 11, IF YOU DO NOT AGREE, YOU MAY RETURN THE SOFTWARE TO YOUR PLACE OF PURCHASE FOR A FULL REFUND, IF APPLICABLE.

1. DEFINITIONS

In this EULA:

- (a) **Device** means a single personal computer, workstation, terminal, handheld computer, telephone, personal digital assistant, or other electronic device.
- (b) **Internet Services** means media and related Internet-based services provided by QSR to support or enhance the use of the Software.
- (c) **License Subscription Term** means the specified period of time to which a license has been purchased for use by the customer or institution to which a user has been granted access.
- (d) **Sample Projects** means examples of projects that can be used to help understand the functionality of the Software and/or start new projects.
- (e) **Server** means a single computer on which Server Software is installed.
- (f) **Server Software** means a version of Software which manages and provides services or functionality to other Devices over a network.
- (g) **Software** means the software accompanying this EULA, being one of the following:
 - (i) NCapture for Internet Explorer;
 - (ii) NCapture for Chrome;
(both **NCapture Device Software**)
 - (iii) NVivo 12 for Mac;
 - (iv) NVivo 12 for Windows;
(both **NVivo Device Software**)

- (v) Interpris;
- (vi) NVivo Server 11;
- (vii) Citrix;

and, in relation to each, includes associated Internet Services.

- (h) **User** means an individual who is your employee or otherwise under your direction and control.

2. LICENSE

2.1 Installation and Use

- (a) In relation to the NCapture Device Software, you may install and use up to five (5) copies of the Software on different Devices.
- (b) In relation to the NVivo Device Software:
 - (i) You may:
 - (A) install and use a copy of the Software on one Device; and
 - (B) install and use an additional copy of the Software on a second, portable Device for the exclusive use of the primary user of the first Device.
 - (ii) The rights to install an additional copy of the Software do not permit use of the Software on both the first and second Device at the same time.
 - (iii) The Software may include more than one version such as 32-bit and 64-bit. You may install and use only one version on a Device.
- (c) In relation to the Interpris Device Software:
 - (i) You may install and use a copy of the Software on one Device;
 - (ii) The Software may include more than one version such as 32-bit and 64-bit. You may install and use only one version on a Device.
- (d) In relation to NVivo Server 11:
 - (i) The NVivo Server 11 Software may contain both Server Software and software which allows a Device to access or use the Server Software.
 - (ii) You may:
 - (A) install and use a copy of the Server Software on a single Server, even if multiple copies of Server Software (for example, 32-bit and 64-bit versions) are included in the Software.
 - (B) install and use the Device Software on any Device solely to access or use the Server Software.

- (C) move the Server Software to a different Server as long as you permanently remove the software from the initial Server.
- (e) In relation to the Citrix Software:
 - (i) You may use a copy of the Citrix Software on one Device in order to run either the NVivo or Interpris software (depending on license purchased) over a remote desktop connection;
 - (ii) The Software may include more than one version such as 32-bit and 64-bit. You may install and use only one version on a Device.

2.2 Documentation

The documentation that accompanies the Software is licensed for internal, non-commercial use only ("**Documentation**"). The Documentation may not be copied, modified or used in any way except as expressly authorized by this EULA.

2.3 Trial

- (a) This clause 2.3 applies to NVivo and Interpris Device Software and NVivo Server 11 only.
- (b) The Software may be licensed on a trial basis. Your rights to use trial Software are limited to the trial period. The trial Software and length of the trial period are set forth during the activation process. You may have the option to convert your trial rights to time limited or perpetual rights subject to payment of a license fee. After the expiration of any trial period without conversion, most features of the trial Software will stop running. During the trial period, the Software is provided "AS IS" with no representation, guarantee or warranty of any kind as to functionality, quality, performance, suitability or fitness for purpose.

2.4 Network Use, Remote Access, Remote Assistance and Sample Projects

- (a) This clause 2.4 applies to NVivo and Interpris Device Software only.
- (b) Network Use. As an alternative to Section 2.1(b) of this EULA, you may install a copy of the Software on a networked Device, for the purpose of permitting one other Device to access and use that licensed copy of the Software over a private network. In those circumstances, you must not use and access the copy of the Software on the networked Device and you must obtain additional licenses for the Software for the purpose of permitting any additional Device to access and use the Software installed on the networked Device.
- (c) Remote Access. You may use remote access technologies to access and use your licensed copy of the Software, provided that only the primary user of the Device (upon which the Software is installed and which is hosting the remote access session) accesses and uses the Software with a remote access Device. These remote desktop rights do not permit you to access and use the Software on both the Device hosting the remote access session and the access Device at the same time.

- (d) Remote Assistance. You may permit any Device to access and use your licensed copy of the Software for the sole purpose of providing you with technical support and maintenance services in respect of the Software.
- (e) Sample Projects. The Software (including the Internet Services) may include Sample Projects. You may copy and modify these Sample Projects and distribute these Sample Projects along with your modifications to, and for use by, other licensees of the Software. Distribution of all Sample Projects by you to other licensees of the Software must be via person-to-person communication. You are not licensed to do any of the following:
 - (i) sell, resell, license, rent, lease, lend, or otherwise transfer for value any Sample Projects;
 - (ii) distribute any Sample Projects as part of any product or service; or
 - (iii) make available any Sample Projects (whether with or without your modifications) on any network computer or otherwise publish, broadcast or make publicly available any Sample Projects.

You must indemnify and keep indemnified QSR from and against any claims, actions, demands and lawsuits and all costs and expenses suffered or incurred by QSR in relation to such claims, action demands and lawsuits (including, without limitation, all attorneys' or legal fees on a full indemnity basis) arising from or in connection with any modifications made by you to the Sample Projects and their distribution.

2.5 Client Access Licenses

- (a) This clause 2.5 applies to Nvivo Server 11 only.
- (b) NVivo Server Client Access License ("**CAL**") Requirements. The Software licensing model consists of one Server Software license and incremental CALs, so that the total cost for the Software scales with usage. You must separately acquire a CAL for each named User that uses the Server Software (**Named User**). Each CAL permits one Named User (using any Device) to access or use the Server Software.
- (c) Reassignment of CALs. You may transfer a CAL from one Named User to another Named User, so long as the transfer is made either (A) on a permanent basis or (B) on a temporary basis to accommodate a unique occurrence with respect to the User from which the CAL is temporarily transferred (for example, use of the CAL by an agency temporarily while a regular employee is on leave).
- (d) Additional CAL Requirements.
 - (i) Single Licensee. CALs, and any future CALs that you acquire, may not be used in conjunction with Server Software licensed to anyone other than you.
 - (ii) Version Matching. Each required CAL must be version NVivo Server 11.
 - (iii) Administration. Up to one User may access or use the Server Software solely for administration of the Server Software, without acquiring any CALs.

3. LICENSE TERMS AND CONDITIONS

3.1 Internet Services

You may not use any Internet Services associated with the Software in any manner that does, or may, damage, disable, overburden, or impair such Internet Services or interfere with any other person's use and enjoyment of them. You may not attempt to gain unauthorized access to any service, account, computer systems or networks associated with the Internet Services.

QSR is not responsible for the contents of any third-party sites or services which comprise part of the Software (including the Internet Services), any links contained in such third-party sites or services, or any changes or updates to such third-party sites or services. QSR provides these links and access to third-party sites and services to you only as a convenience, "AS IS" and without warranty of any kind and the inclusion of any link or access does not imply an endorsement by QSR of the third-party site or service.

3.2 Reservation of Rights and Ownership

- (a) QSR reserves all rights not expressly granted to you in this EULA. The Software is protected by Australian copyright and international copyright laws. QSR (or, where indicated, its suppliers) own all copyright and other intellectual property rights in and to the Software. The Software is licensed to you, not sold. Your license rights under this EULA are non-exclusive. This EULA does not grant you any rights to use any trademarks or service marks of QSR.
- (b) The Software may include software subject to copyright of third parties. The names of the third parties and the notices and/or additional terms and conditions which are required by those third parties are located in items 1 and 2 respectively of each of the respective Schedules. By accepting this EULA, you are also accepting the additional terms and conditions, if any, set out there.
- (c) In relation to NVivo Server 11, notwithstanding any other provision in this EULA, neither this EULA nor any CAL permits any person to implement any functionality contained in the Software (including without limitation communication protocols used by the Software) in any software installed on a Device accessing or utilizing the Server Software.

3.3 Limitations on Reverse Engineering, Decompilation and Disassembly

You must not:

- (a) alter, decompile, disassemble, merge, modify or adapt the Software in any way;
- (b) copy, reproduce, translate, adapt, vary or modify the Software without the prior written consent of QSR, except as expressly authorized by this agreement or by law; or
- (c) provide or otherwise make available the Software in any form to any person other than those permitted by this EULA, without the prior written consent of QSR.

3.4 No Rental/Commercial Hosting

You may not rent, lease or lend the Software, or make the Software available through any commercial hosting or similar service or arrangement.

3.5 Consent to Use of Data

You consent to QSR and its affiliates collecting and using technical information gathered as part of the support services provided to you, if any, related to the Software. QSR may use this information solely to improve its products or to provide customized services or technologies to you and agrees that it will not disclose this information in a form that personally identifies you. 3.6 Additional Software and Services

- (a) This EULA applies to all updates, supplements, add-on components, or Internet Services components, of the Software that QSR may provide to you or make available to you after the date you obtain your initial copy of the Software, unless they are accompanied by separate terms that are expressly stated to apply. QSR reserves the right to discontinue any Internet Services at any time.
- (b) Any video content made available through YouTube is provided to you on the basis of you agreeing to be bound by the YouTube Terms of Service, see <https://www.youtube.com/t/terms>.

3.7 Upgrades and Updates

To use the Software as an upgrade of another product, you must first be licensed to use a product identified by QSR as eligible for the upgrade to the Software.

If you are not using a licensed copy of the Software, you are not permitted to download, install or use any upgrades or updates to that Software.

3.8 Automatic Update

- (a) This clause 3.8 applies to NCapture Device Software and NVivo Server 11 only.
- (b) Software on your licensed Device may periodically check with QSR for updates to the Software. If found, these updates may be automatically downloaded and installed on your licensed Device.

3.9 Mandatory Activation and Education Pricing and Student Edition Software

- (a) This clause 3.9 applies to NVivo Device Software and NVivo Server 11 only.
- (b) Mandatory Activation. THERE ARE TECHNOLOGICAL MEASURES IN THIS SOFTWARE THAT ARE DESIGNED TO PREVENT UNLICENSED USE OF THE SOFTWARE. You may not be able to exercise your rights to the Software under this EULA after a finite period of time unless you activate your copy of the Software in the manner described during its installation or launch. You may also need to reactivate the Software if you modify any Device upon which the Software is installed or any alteration is made to the Software or other software (such as operating systems). During activation, the Software will send information about the Software and the Device to QSR. This

information includes the product ID and version of the Software, license key, Internet protocol address of the Device, and information derived from the Device hardware configuration. BY USING THE SOFTWARE, YOU CONSENT TO THE TRANSMISSION OF THIS INFORMATION. QSR will use these technological measures to confirm you have a legally licensed copy of the Software. An additional license is required if you install another copy of the Server Software on the same Server (whether in a separate partition, by using server emulation software, or otherwise) or to install or run a copy of the Server Software on a different Server.

3.11 Validation

- (a) This clause 3.11 applies to NVivo and Interpris Device Software only.
- (b) The Software will from time to time verify that the Software has been activated and is properly licensed. During a validation check, the Software will send information about the Software to QSR. This information includes the product ID and version of the Software, license key, Internet protocol address of the Device, and information derived from the Device hardware configuration. QSR does not use the information to identify or contact you. BY USING THE SOFTWARE YOU CONSENT TO THE TRANSMISSION OF THIS INFORMATION. If the Software is not properly licensed, the functionality of the software may be affected. For example, you may need to reactivate the Software, or receive reminders to obtain a properly licensed copy of the Software. 4. GENERAL CONDITIONS

4.1 Termination

- (a) Without prejudice to any other rights under this EULA or at law, QSR may terminate this EULA if you fail to comply with any terms and conditions of this EULA. In such event, you must completely and irretrievably remove all copies of the Software from any Server or Device upon which it is installed.
- (b) In relation to NVivo 12, NVivo Server 11 and Interpris, the Agreement shall terminate on the expiration of the time limited License (Subscription Term) unless terminated earlier in accordance with this EULA.

4.2 Limited Warranty

YOU ACKNOWLEDGE THAT THE SOFTWARE CANNOT BE GUARANTEED ERROR-FREE AND FURTHER ACKNOWLEDGE THAT THE EXISTENCE OF ANY SUCH ERROR SHALL NOT CONSTITUTE A BREACH OF THIS EULA.
